

## To resident tax exempt households per capita rate

# Information on Priority Support Benefits for Low-Income Households (30,000 yen/household)

Procedures are required to receive it

- The priority support benefit for low-income households (30,000 yen per household) is a new benefit to support households exempt from per capita resident tax whose lives are especially affected by the soaring prices of energy, food, etc., or households with a sudden change in household finances from January - September, 2023.
- Procedures are required to receive the benefit.

### Benefit payment amount

30,000 yen per household

※Paid to the head of the household.

### Benefit payment period

Usually about 3 weeks after the day Utsunomiya City receives the confirmation notice (or application form).

※Depending on the situation, it may take 3 or more weeks.

### Payment target and application necessity

#### Households eligible for payment (Households for which any of the following apply)

Households for which all members are "**exempt from per capita resident tax**" in 2023

Households with decreased income from January - September 2023 which have an income that is "**resident tax exempt equivalent**" (Sudden change in household finances)

Confirmation notices will be sent sequentially starting July 7 from Utsunomiya City (**Return service required**)

Procedures deadline: October 31, 2023 (Tuesday)

Confirmation notices will be sent to persons who have resident registration in Utsunomiya City as of June 1, 2023.

#### Application required



Application period: July 7, 2023 - October 31, 2023 (Tuesday)

# Benefit Payment Procedure

## I. Households exempt from resident tax (per capita basis) in 2023

- Eligible households will receive a confirmation notice with payment details and confirmation items from Utsunomiya City.
- After confirming the contents, please **send it via postal mail** in the enclosed self-addressed envelope.



### 【Confirmation items】

- ① Make sure there is no mistake in the written benefit transfer bank account number
- ② Make sure it is not a household with only dependent relatives of those who are subject to resident tax, etc.



## II. Households with decreased income due to sudden unexpected changes in household finances and in which all members of the household became resident tax exempt equivalent\* (Sudden change in household finances)

\*Resident tax exempt equivalent means that the estimated annual income (any monthly income x12 from January to September 2023) of each member of the household is at or below the resident tax per capita rate tax exemption level.

(Ex.) Estimated annual salary income exempt from resident tax (for Utsunomiya City) · For single occupant households: 970,000 yen or less  
· For dual occupant households (1 dependent): 1,480,000 yen or less  
\*For single parent households (2 children or less): less than 2,044,000 yen

- To receive the benefit, **an application is required**.
- Please fill in the required items on the application form and submit it together with the attached documents to the following mailing address.



If you apply for the benefit due to a clear decrease in monthly income in advance of the decrease in income, you may be accused of fraudulent receipt (fraud).



Please be careful of priority support benefit **“bank transfer fraud”** and **“personal information fraud”** aimed at low-income households!



If you receive a suspicious phone call or mail at your home or workplace, etc. supposedly from the national, prefectural, or municipal government (employee), etc., please contact the Call Center.
